



Additional investment in Oklahoma, Atoka County

Tenaska, with a presence in Oklahoma for more than 25 years, is considering a natural gas-fueled power plant in the area. Similar to the existing Tenaska Kiamichi Generating Station in southern Pittsburg County, this facility would add reliability to the regional electric grid amid growing power demand, as well as generate jobs, tax revenue and other local economic benefits.

Proposed natural gas generation

Tenaska is evaluating the development of a natural gas-fueled power plant capable of generating up to 1,000 megawatts (MW). Natural gas remains the cleanest fossil fuel for power generation, and the market demand for natural gas generation is growing amid an influx of renewables like wind and solar that provide intermittent power.

Location: Tenaska has identified a location in northern Atoka County for this effort, called Drover Generating Station. The facility would be a simple-cycle peaking plant, which is smaller in design from the combined-cycle plant at Tenaska Kiamichi Generating Station.

Timeline: Development is expected to span three to five years. Pending all necessary approvals and permits, the earliest construction start would be late 2027.

Economic benefits: Construction and operation of a new natural gas-fueled power plant would generate significant economic benefits in the region:

- Construction of the facility would create hundreds of jobs and millions of dollars in contracts for construction-related goods and services from Oklahoma companies
- Operation of the facility would provide jobs for an estimated 10 full-time employees, resulting in more than \$2.5 million in salaries and payments to local contractors and vendors annually
- After the start of operation, the plant would pay millions of dollars in local property taxes over its lifetime
- The plant and its employees would support various local efforts and organizations, through volunteer hours and/or monetary support

Tenaska has been a good business neighbor in Oklahoma for more than 25 years. We have built positive relationships here and feel like a welcomed and valued member of the community.

Since 2003, Tenaska Kiamichi Generating Station has operated in a safe and responsible manner, while also providing stable jobs and tax revenue. The plant team collaborates with community leaders, first responders, the chamber, the schools and more. This effort would be additive to the benefits provided by Tenaska Kiamichi and is not intended to replace that facility.

We look forward to working with the Atoka County community to make this additional investment a reality.
